After school and summer programs for elementary and middle school youth. Emergency assistance including food bank, energy assistance, Salvation Army vouchers, parenting classes, ESL, and resource/referrals. Services are only provided in Rochester. This is a program of TOGETHER!

Provides confidential services related to protection orders, divorce, parenting plans, referrals to lawyers, legal and medical advocacy, interpretation and translation services, personal support and counseling.

Childcare for families in crisis. Service is for children birth to 6 years of age. Mon - Fri 7am to 6pm.

*** Parent to Parent Support Program ~ 352-1126**

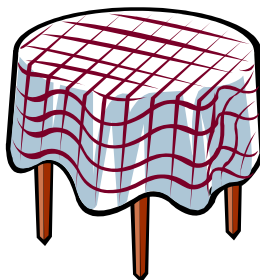

*** CHOICE Regional Health Network**

Provides application assistance, consumer information, and education regarding health insurance options through Washington Basic Health and Children's Medical.

*** Community Action Council ~ 438-1100 ext. 2**

Women, infants, and children (WIC), maternity case management and support services (nutrition, energy assistance, food stamp outreach, weatherization, minor home repair, food bank, and information and referral).

*** Providence Sound Home Care**

—Maternity Support Services ~ 493-5934

Provides preventive health and education services to women who are either pregnant or within the first two months of the postpartum period. Services are designed to supplement medical visits.

Immigration legal services, green cards, work permits, visa petitions, citizenship. Representation in Immigrant Court, INS offices, U.S. Consulates and Embassies.

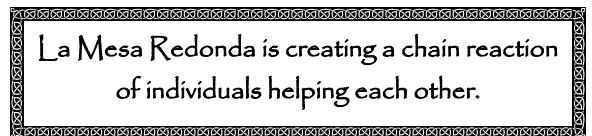
